

## **CLARIFICATION TEXT OF THE LAW ON THE PROTECTION OF PERSONAL DATA**

**The Southeast Anatolian Exporters Associations General Secretariat**, works to increase exportation by organizing exporters and ensures the development of foreign trade in accordance with the interest of the country, also demonstrates its sensitivity in the industry regarding the security of personal data. In this sense, we pay great attention to the processing, protecting, and deleting personal data of general quality, belonging to the contest's participants, in accordance with the Law on the Protection of Personal Data number 6698, secondary regulations (regulations, notifications, circulars) that have been or will be put into effect subject to the Law, and decisions made or will be made by the Protection of Personal Data Council. With the awareness of this responsibility, we process your personal data as described below and within the limits ordered by the legislation as "Data Supervisor" in the form defined in the law.

### **1. INFORMATION ABOUT THE DATA SUPERVISOR**

By operation of law, "Mücahitler Mahallesi Ş. Ertuğrul Polat Caddesi No: 3/1 Şehitkamil Gaziantep " **The Southeast Anatolian Exporters Associations General Secretariat** resident is a Data Supervisor

### **2. PURPOSES OF PROCESSING PERSONAL DATA**

Your personal data will be moderately processed, limited to duration required for; getting to know the competitor and inspecting whether they conform to the conditions of the contest or not, obtaining data as per the regulations to communicate with the participant and processing it in the recording system for execution of the data supervisor's responsibilities, carrying out their accounting (financial processes) processes of the data, and detecting and implementing our commercial, financial, legal, and social businesses and goals, in accordance with the purposes specified in the FABRIC Cloth Design Contest's Specification, and limited to the matter of application.

### **3. THE TRANSFER OF PERSONAL DATA**

Personal data of the participant within the above purposes will be transferred to;

- The Southeast Anatolian Exporters Associations Board of Management members,
- The Southeast Anatolian Exporters Associations 's employees with administrative and/or representative authorities in all relevant administrative, commercial and social units and branches, and information processing units within the scope of Doku Fabric Design Contest,
- The Southeast Anatolian Exporters Associations's supreme organizations and administrative units, other subsidiaries,
- Cooperating institutions and organizations, their employees and public institutions and organizations, audit and supervision institutions and organizations, real persons and private legal entities,
- Members of the The Southeast Anatolian Exporters Associations.

#### **4. RIGHTS OF DATA OWNERS UNDER THE LAW**

Contact The Southeast Anatolian Exporters Associations at any time about your personal data so;

1. You can find out whether it has been processed, the purpose of processing and whether it is used in accordance with its purpose, and ask for information about it if it has been processed,

2. You can learn about the third parties with whom your information is shared within the country or abroad, in accordance with the law,

3. You may ask for correction if you believe that your information is not being processed thoroughly or correctly,

4. Within the scope of 7th article of the Law, you may request the deletion or destruction of your information in accordance with the conditions provided for in its article,

5. You may ask third parties to whom your information is transferred to be notified of your requests specified in paragraphs (c) and (d) and to perform the same actions,

6. You may object to a result born against you due to your information being analyzed using automated systems, or if you believe that it has been recorded or used illegally, and you have been damaged for this reason, you may request that the damage be indemnified.

If your application for these purposes requires an additional cost, you will pay the fee determined by the Notification on the Procedures and Principles of Appealing to the Data Supervisor established by the Personal Data Protection Council. If your appeal is answered in writing, you will not be charged up to the first 10 (ten) pages, and a transaction fee of 1 TRY will be charged for each page after the first 10 (ten) pages. If the answer to your appeal is given in a recording medium such as a CD, flash memory, you will be charged the same as the cost of the recording medium. Your requests in your a will be concluded as soon as possible and no later than 30 (thirty) days, depending on the nature of the request.

In your appeals, your first and last name, signature, T.R. identification number, residence or workplace address, e - mail address, telephone and fax number, the presence of the elements subject to the request is mandatory in accordance with the “Procedures and Principles of Appealing to the Data Supervisor”. Appeals that do not contain this information will be rejected by the The Southeast Anatolian Exporters Associations. In order to benefit from your rights under the law, you can submit your applications to the The Southeast Anatolian Exporters Associations in writing and visit the website of the Personal Data Protection Council for detailed information.

2. after completing the form located on <https://www.gaib.org.tr> and signing it with your secure electronic signature “in accordance with the Electronic Signature Law No. 5070, the form needs to be send with a secure electronic signature registered to the [gaib@hs01.kep.tr](mailto:gaib@hs01.kep.tr) e-mail address,

In the application which includes statements about your explanations and requirements for using your right stated above as the Personal Data Owner; the requested matter needs to be clear and understandable, in the event that the requested matter is related to you or you are taking action on behalf of someone else, you must submit a special power of attorney certified by a notary in this regard.

The Southeast Anatolian Exporters Associations always reserves the right to amend this text of clarification for reasons arising from the law, secondary regulations and decisions of the board. Changes to the clarification text and the current text will take effect immediately as of the date of notification that has been sent to you.
